

Ministerial Decision 25611/02/03-03-2026 “Amendment of the decision 129809/02/31-10-2024 of the Minister of Education, Religious Affairs and Sports ‘Appointment of the members of the Supervisory Council of the Medresses of Thrace’” (Y.O.Δ.Δ.1277)

We hereby decide:

To amend decision 129809/02/31-10-2024 “Appointment of the members of the Supervisory Council of the Medresses of Thrace” (Y.O.Δ.Δ.1277), with regard to the composition of the Supervisory Council of the Medresses of Thrace, the appointment of the President and Deputy President of the Council, as well as the appointment of the Deputy Secretary of the Council, as follows:

- A. We replace the following members of the Supervisory Council of the Medresses of Thrace for the rest of the Council’s term, as specified in decision 129809/02/31-10-2024, that is, until November 14, 2027, as follows:
 - 1. SERIF EMIN son of ALI, ID No. A02374475, Mufti at the Muftiate of Didymoteicho, replacing OSMAN HAMZA son of ALI OSMAN, ID No. AE 883768, former Acting Mufti of Didymoteicho,
 - 2. SERIF DAMADOGLU GIASIAR son of ACHMET, ID No. A00005291, Acting Mufti with a temporary assignment as a Mufti at the Muftiate of Komotini, replacing TZICHAT CHALIL son of BILAL, ID No. A00673125, former Acting Mufti of Komotini,
 - 3. IMAM SOUCHEIP REMZI, ID No. A01086984, Acting Mufti with a temporary assignment as a Mufti at the Muftiate of Xanthi, replacing CHEMSERI NEZNTEN son of CHUSEIN, ID No. AZ 411631, former Acting Mufti of Xanthi,
- B. We appoint SERIF EMIN, Mufti of Didymoteicho, as President of the Council, with SERIF DAMADOGLU GIASIAR, Acting Mufti of Komotini, as Deputy President, replacing TZICHAT CHALIL and OSMAN HAMZA, respectively.
- C. We appoint CHRYSIKOPOULOS KONSTANTINOS son of Dimitris as Deputy Secretary of the Council, a seconded teacher at the Regional Directorate of Primary and Secondary Education of Eastern Macedonia and Thrace, with ID No. A00628252, replacing MARIOS KOUKOUZELIS son of GEORGIOS, an employee in the administrative and secretarial staff (Secondary Education level) of the Regional Directorate of Primary and Secondary Education of Eastern Macedonia and Thrace, with ID No. A00377959.

In all other respects, Ministerial decision 129809/02/31.10.2024 “Appointment of the members of the Supervisory Council of the Medresses of Thrace” (Y.O.Δ.Δ. 1277) shall remain in force.
