Ministerial Decision No 141287/Θ2/26-11-2024 “Composition of the School Boards of the Medresses of Komotini and Xanthi” (B’ 6742/10-12-2024)

A. the School Board of the Medresse of Komotini shall be composed as follows:

D. The term of office of the School Boards of the Medresses of Komotini and Xanthi shall be two (2) years, starting on the 2nd of January 2025 and ending on the 31st of December 2026.
